Call for Presentations

The conference is accepting applications for Workshops, Presentations, and Panel Discussions for the upcoming 25th Annual South Texas Family Support Conference. The conference will be held June 25th-27th at the Inn of The Hills Kerrville, Texas. Submissions are used by the committee to make an informed decision during the selection process and provide conference attendees information about your session. **The deadline for applications is Monday April 22, 2019**

Submission Topics

The conference welcomes submissions on topics including adult mental health, children's mental health, chemical dependency, intellectual disabilities, health and wellness and physical/integrated health.

Session Format

Sessions are 60-90 minutes long and must include time for audience questions. Most sessions will have between 30 and 40 attendees. Presenters will be required to provide 40 copies of presentation materials for the session (handouts, brochures, etc.).

Submission Instructions

1. Presentation description must be no longer than 50 words.
2. A complete application must include resume/vitae for each presenter and co-presenter.
3. Only one application should be submitted for a Group Presentation. Co-presenter information should be included in the Co-Presenter Form. Names, titles and email addresses of all group presenters should be included in the application.
4. Please indicate if you are interested in presenting your workshop more than once during the conference. *Consumers and their families would like to attend as many presentations as possible, providing a minimum of two sessions would assist with this request.*
5. Please indicate if you are able to provide your presentation in English and/or Spanish. *Many of the conference attendees are primarily Spanish speaking and encourage presentations in both English and Spanish.*

Submission Deadline

Applications must be submitted by **Monday April 22, 2019**. Applicants will be notified by **April 29, 2019** if the application has been accepted.
